The Neighbourhood Plan is totally different from the Local Plan, which contains proposals to remove large parts of Buckinghamshire from Green Belt. We don't get to vote on the Local Plan, although we can comment in the 6 week consultation which starts on 7th June, after which an independent adjudicator will consider all the comments (there are sure to be quite a few). There has been some confusion on this, and so we have more information about them both below.

So perhaps while you're enjoying these events and voting in the referendum spare a moment of thought for the tireless efforts of all the residents who put so much time and effort into making our village community so special. It really is amazing what can be achieved when people work together!

Thoughts from the Chair, by Nicki Gilham

I recently read the short publication, From Jordans, A Quaker Shrine Past Present, by Ernest Warner, 1921, and felt that the words 'Passing across the road from the Hostel the eye is attracted by the red roofs and chimneys of Jordans Village, and here, to bring the picture into focus, it is not necessary to reconstruct the past, but to let the imagination blend the present with the future', were still as true today as they were when written.

This is particularly so, as we are in our centenary year where the events being planned by the amazingly committed Centenary Committee are a true blend of the past, but also the future, with the final event being the burying of the time capsule to be found by generations to come. Of course the discussions surrounding the Village Hall also demonstrate the desire to blend the best of the present with the future and consider how the legacy of a Village Hall will remain for generations to come. Furthermore, the huge coming together of people to write to our local MPs and councillors to make comments against the proposed removal of Jordans from the Green Belt has been another indication of our desire to preserve the past for the benefit of the future - (suffice it to say that we have a lot more debate to happen in this regard, along with the upcoming need to support the progress of our Neighbourhood Plan).

In further support of capturing the past, yet thinking of the future, I attended the launch of the Seer Green and Jordans Living Village project - a fascinating evening in the village hall seeing some of the historic photographs of our village and surrounding areas, whilst understanding the project team's plan to capture our history using modern technology allowing future generations to enjoy unravelling our history in an innovative and appealing way.

In talking to many of the residents of our village recently, it's clear that whilst some divisions in thought do arise, there is a huge desire for the protection of Jordans - its past and present - and separately the desire to look for thoughtful changes to protect the sustainability of the village for future generations.

Whilst there can be discomfort in some of the conversations, there is one overriding common denominator by all and that is to maintain our strong community spirit and values, ensuring that our children's children can still enjoy playing on a quintessentially English village green against a backdrop of traditional dwellings that would still be familiar to the village founders. I would encourage everyone to share their views and join in the many debates and discussions that are underway, to ensure the character of our village and the surrounding countryside is protected for the benefit of future generations.

About the Village Store

Jordans Village Community Store, founded in 1922, is an independent community store, owned, operated and controlled by the Village. It is run by a combination of part-time staff and volunteers from the local community.

It started in a very small way in the front room of one of the early workers' cottages by the Village Green. In 1921, the brick building, now used as the Estate Office, was erected and a proper store opened.

The store is now a general grocers, with green groceries, an off-licence, a sub post office and café. It caters for online orders, and home delivery. We care about where our food comes from and how it is packaged, for example bread is baked for us at local bakeries in Chalfont St Giles and Little Chalfont; our milk is directly from a from a herd in Staffordshire; vegetables are via Blackwells - who pride themselves on locating the freshest fruit and vegetables and not covering them in plastic!

The Store also serves as a natural meeting place for many of those living around the village, so why not come in and receive a warm welcome from our friendly staff and team of volunteers who are all eager to help you.

What is the difference between a Neighbourhood Plan and a Local Plan?

The Neighbourhood Plan is created by you for your Parish Area.

A neighbourhood plan is supposed to represent the plan the local community has for the area and as such must be approved by the local community via a referendum. The Chalfont St Giles Neighbourhood Plan has been in the making since 2013. The contents of the plan were created in response to several consultations, questionnaires and public events to ascertain what the residents of Chalfont St Giles Parish would like to see happen to their Neighbourhood Area in the years running up to 2036. This information was collated into a plan and then examined by a Chartered Town Planner specialising in Neighbourhood Development Plans to ensure that the document was legal and adhering to planning legislation.

The final step in creating a Neighbourhood Plan is to have a referendum to see whether the residents of the Parish accept the plan proposed for the future development of their neighbourhood. If the plan is accepted in the Referendum, the Parish Council will adopt the plan and it will be used to guide the planning authority responses to planning applications within the Parish.

The Neighbourhood Plan for Chalfont St Giles Parish is going to referendum on 13 June.

You have already played a part in creating this Neighbourhood Plan. It represents the views of the residents of the Parish.

In this referendum, you are not being asked to vote on the District Council's "Local Plan" -see below

Please vote in this referendum to accept or reject your NEIGHBOURHOOD PLAN

The Local Plan is created by planning experts adhering to Government Guidelines

A local plan is a statutory requirement of the local planning authority i.e. they have to have an up-to-date Local Plan – the Local Plan has to be evidenced based and this evidence and the contents of the plan have to be declared sound by a government appointed inspector. Whilst people have the chance to make comments on the plan it is the Government appointed inspector who decides if the plan can be adopted subject or not to any modifications.

Chiltern and South Bucks Council are the planning authority for Chalfont St Giles Parish. Their Local Plan will be going to consultation on 6 June for 6 weeks. You can comment on this plan and your comments will be taken into consideration by a government appointed inspector but you will not get to vote on whether this plan is accepted or not.

The Chiltern and South Bucks Local Plan has been now been approved by both councils (on 14 and 15 May 2019).

This plan is based on evidence and you as a member of the public do not get to vote on whether to accept this plan or not.

<u>Neighbourhood Plan Referendum – 13th</u> June 2019...and more on the Local Plan

As you will be aware, a Referendum relating to the adoption of the Chalfont St Giles **Neighbourhood Plan** will be held on 13th June 2019.

The question which will be asked in the Referendum is:

"Do you want Chiltern District Council to use the Neighbourhood Plan for Chalfont St Giles to help it decide planning applications in the neighbourhood area?"

The Referendum will be conducted in accordance with procedures which are similar to those used at local government elections.

The Neighbourhood Plan aims to give more say to local people about planning matters in their area. The Chalfont St Giles Parish was formally designated as a Neighbourhood Area on 20th December 2012 and the CSG Submission Neighbourhood Plan 2014 – 2036 sets out planning policies which aim to contribute towards the achievement of sustainable development for Chalfont St Giles Parish – including Jordans.

If a MAJORITY of voters agree to the Neighbourhood Plan on 13th June, CDC Planning Officers will be obliged to consult this document when deciding on any planning application in the Parish.

Some of the key issues addressed in the Neighbourhood Plan include

- The existing community facilities in the Parish such Milton's Cottage, Chalfont St
 Giles Memorial Hall, The Reading Room, Jordans Meeting House, Jordans Village
 Store and Jordans Village Hall are much valued and it is important that these are
 protected and enhanced for future generations
- Public accessibility to the natural environment should be improved. Some
 footpaths are not regularly maintained and are difficult to use. The natural
 environment around the villages is valued and should be protected and enhanced
- There is a need to protect and support local shops and businesses as they play a key role in providing supporting services and facilities for residents. There is a need to support local tourist attractions by protecting the Parish's outstanding natural environment and historic assets.

The specified documents are:

- The Chalfont St Giles Neighbourhood Development Plan (submission version);
- Report of the independent examiner;
- Summary of the representations submitted to the independent examiner;
- Statement of the local planning authority's satisfaction that the draft neighbourhood plan meets the basic conditions specified by statute and complies with the provision made by or under Section 38A and 38B of the Planning and Compulsory Purchase Act 2004 (Chalfont St Giles Neighbourhood Plan – Final Consideration of Examiners Report);
- This information statement;
- A statement that sets out general information about town and country planning including neighbourhood planning and the referendum.

We encourage you to review again the Neighbourhood Plan as there are particular sections that specifically relate to Jordans. In essence the Plan very much supports keeping the Green Belt, discusses planning policy sentiment as well as how to maintain and develop broader aspects of our Community. Certainly, within JVL we tend to consider the spirit of the Neighbourhood Plan as part of our overall considerations for matters across the Village.

Meanwhile, there is the Local Plan. What happens next with this?

The Local Plan is a statutory requirement of the local planning authority - it has to be evidenced based and this evidence and the contents of the plan have to be found "sound" by a government appointed inspector. Whilst people have the chance to make comments on the plan it is the Government appointed inspector who decides if the plan can be adopted subject or not to any modifications.

Our local plan was passed by both Councils on the 14th and 15th May - the next step is to publish it for a consultation period of 6 weeks.

Many residents of Jordans wrote to our local Councillors and these comments have been acknowledged and are being further considered. During this next period we will have the chance to comment either for or against the Local Plan

as it is published and these comments will be considered by the inspector.

It is important to note that while you can take part in the consultation on the Local Plan, and write to the examiner and add further comments and observations, we won't be given any chance to vote for the Local Plan itself.

The timeline as we understand it is:

- June 2019 Formal Publication of the draft Local Plan
- 7th June 2019 Regulation 19 public consultation, over a period of 6 weeks
- Mid to Late July 2019 Once the consultation period is complete, the Local Plan
 together with responses to the consultation and any further comments and
 objections would go before an independent examiner for their consideration. The
 examiner can ask for changes to the Local Plan or even reject the plan as they see
 fit.

We received a statement from Cllr Peter Martin (Member for Little Chalfont; Cabinet member for Planning and Economic Development Chiltern District Council; County Councillor for Gt Missenden Bucks County Council) on 14th May 2019.

In connection with the possible removal of Jordans from the Green Belt, he notes that 'it reflects policy from central government in the National Planning Policy Framework (NPPF)'.

He noted however that because of this the Council have "undertaken a townscape character assessment" which should help to shape and establish what development would or wouldn't be permitted in the future.

Cllr Martin went on to state that "Following discussions at our Group meeting last night and comments from your local councillors this will now be further reviewed with regard to Jordans. Our design policies would also apply and of course part of the Village is in a conservation area which remains and I understand that Jordans Village Ltd has covenants which also offer protection to the area. All of this will contribute to the protection the Village has. Let me assure you that while keeping the character and style of Jordans is very important to you and your residents it also important to us."

In conversations with Cllr Peter Martin, he has also indicated:

The government's National Planning Policy Framework states that villages should not be included in the Green Belt if they reduce its '**OPENNESS**', and it is on this basis that the Council's legal advisors have advised it that the Green Belt around Jordans should not extend to include the village itself. We are questioning what evidence there is for this crucial definition and Jordans residents will be invited to express their views on this proposal in the forthcoming consultation.

It is important to note that, even if Jordans were removed from the Green Belt, this would not give the green light to developers to do as they wished. The fact that an area is not in the Green Belt does not automatically make it inevitable, likely (or even possible) that it will be developed. In Jordans' case, there are two reasons for this:

- Jordans Village would remain (partly) in a Conservation Area. The Conservation
 Area status is not affected by the Local Plan and actually offers more protection for
 communities against unsuitable development than is provided by inclusion in the
 Green Belt.
- 2. Jordans Village Limited's Management Scheme remains in place to exercise influence over planning decisions.

However, Cllr Peter Martin confirmed that our local councillors are seeking further protection for Jordans regardless of whether or not the centre of the village remains in the Green Belt.

So the Green Belt is promoted in the Neighbourhood Plan - but proposed to come out of the Local Plan?

Yes, that's the conflicting situation that we are in...but by voting in the Referendum to support the Green Belt, that sentiment will stay within the Neighbourhood Plan.

If ongoing reviews of the Local Plan lead to the Examiner agreeing to the retention of Jordans in in the Green Belt – we will know that many of the views of our residents have been heard and acted upon!

If the Local Plan as is gets agreed and parts of Jordans are removed from the Green Belt,

JVL will continue to operate its Planning Policy in the spirit of the Neighbourhood Plan, and parts of Jordans will continue to be protected by the Conservation Area.







"Our Living Village" project – we have liftoff!

More than fifty villagers participated in the launch meetings in Seer Green and Jordans, demonstrating the level of interest in this project to produce an in-depth computerised history of our two communities. The lively discussion touched upon the important historical relationship between the two communities. Who knew, for example, that the 17th century Quaker Meeting used to alternate between our two villages? Or that the layout of the Jordans Meeting House graveyard is based upon the memory of just one man living in Seer Green? Or how much Seer Green's lace-making tradition is still thriving to this day?

The next steps in the project will include selecting the initial historical themes that we'll be investigating in depth, kicking off the population census and family research, and assembling the historical maps that will be used as a graphical basis for the village histories. Training will be available in September for those interested in mastering the software that will be used to assemble the on-line history, but the great majority of roles require no such technical skills – just a love of our two communities and an interest and willingness to get involved.

Paws for Thought

Look Out - Ticks About!

My daughter Donna suggested to me that this month's 'Paws for Thought' should address the subject of ticks, having contracted Lymes Disease herself whilst living in Germany.

Ticks inhabit the countryside all year round but are most active during the spring through


to autumn. Fossil records suggest that the tick has been around for at least 90 million years! We now have around twenty species in the UK. What has become known as the sheep tick is the most common, which also feeds on deer, cattle, other wild animals and pets.

Ticks come from the spider family and are blood sucking and egg shaped. They don't fly or jump, but crawl or drop onto dogs, cats and humans. Adult ticks are more easily visible and therefore easier to remove. It is the adult tick that can carry diseases such as Lymes Disease. Ticks go through four life stages: egg, six-legged larva, eight-legged nymph, and adult. They are around 3mm in length. It is really important to check your dog over after a walk especially if you've been walking near long grass, bracken, or places where sheep or deer can be found. To check your dog for ticks run your hands over its coat. A tick will feel like a small bump and tend to be found on dog's heads, necks, ears or paws. Regular brushing also helps to detect them. Ticks carry a natural anaesthetic in their saliva, which means your dog may not be aggravated by the presence of a tick bite straight away.

There are a number of devices available from pet shops or online that will remove a tick. The key thing is not to let the head break off and remain on the body as it will then expel blood back into your dog. It is important not to squeeze the body of the tick and to get as close to the dogs skin as possible. Pull the tick out with a firm upward movement. Donna now lives in Scotland and has removed many ticks from her Jack Russells over the years and advocates twisting using plastic pinchers. It is advisable to wear latex gloves when removing a tick and to clean the area with disinfectant afterwards parting the fur to do so.

Rather ironically whilst sitting writing this article I noticed a black mark on the nose of Freddie, a Cockapoo that was staying with me. On investigation I saw that his nose was bleeding and after washing the area I saw a tick nestled in his fur. I managed to successfully remove it, head and all, with a Ticklasso, manufactured in Sweden. The tick will still be alive if you manage to remove it with its head on. Ticks can swim so don't flush down the loo! Freddie was going home that night so I kept the tick for his owner because some veterinary practices will get them checked to see if they are carrying any harmful microbes. Although even if the tick is carrying a harmful microbe it doesn't necessarily mean your dog will contract it. There are all sorts of preventative measures one can take to avoid ticks such as collars and tablets, which your vet can advise you on. Funnily, in all of the fourteen years that I've been looking after dogs this was the first time I had found a tick on a dog in my care!

New rules for play

Our basketball hoop is a popular facility, but the only suitable location for it is in the Village Hall car park.

As such JVL has introduced new rules with immediate effect to reduce the repetitive noise caused by play with normal basketballs, and to provide some respite for neighbours.

From now on, players must only use a soft ball to play with our basketball hoop - basically, an indoor football which has a tennis ball type surface.

While we have provided one, if our soft ball is not available for any reason then players must bring their own soft surfaced ball. Normal basketballs are no longer allowed due to the noise they create.

The only other rules are that there is to be no play after 8pm, on Bank Holidays, or when the Hall is in use. Many thanks for your co-operation.
